

# The Beach at Craig Ranch

## Rules and Regulations

### General Facility

- a. The Beach is organized to provide a recreational, fun and safe social environment.
- b. **EVERYONE WHO ENTERS THE BEACH ASSUMES ALL RESPONSIBILITY AND LIABILITY WHEN PLAYING OR BEING A SPECTATOR AT THE BEACH. PLAY OR SPECTATE AT YOUR OWN RISK.**
- c. No outside food or beverages. Players and spectators will be allowed to bring in transparent plastic water bottles/jugs, **filled with water only**. No one is permitted to bring alcoholic beverages into the Facility, and no alcoholic beverages are permitted to leave the Facility. The Beach must adhere to TABC laws. Bags may be checked upon entering the facility plus you may be asked to open your water container.
- d. The Beach wants to provide a junior friendly atmosphere. For such reason, alcohol will not be sold on the premises from June 1 through July 31 each year during the hours of 8 a.m. to 4 p.m., Monday through Friday, with the exception of July 4th. The Junior Event and Adult Event areas will be separated as much as possible. Alcohol should never enter the Junior Event play area.
- e. No children should be left unattended at the Facility.
- f. Showers and sand are for **player use only**. Playing in showers and digging holes, building sand castles or throwing rocks in the sand are strictly prohibited.
- g. No smoking or other tobacco product use is allowed.
- h. The use of any illegal substances is prohibited on The Beach property, including parking lots and surrounding areas.
- i. No glass containers, aluminum cans or sand toys are allowed in The Beach property.
- j. No skateboards, bicycles, scooters, roller blades, or roller skates are allowed.
- k. No gambling is allowed on The Beach property.
- l. Except for animals assisting those with disabilities, no pets are allowed on The Beach property.
- m. The possession of weapons, explosives or firearms while on The Beach property, including parking lots and surrounding areas are strictly forbidden.
- n. The Beach is not responsible for any items lost or stolen on The Beach property, including parking lots and surrounding areas. Also, The Beach is not responsible for any items left in a locker or left in the care of an employee of The Beach.
- o. Theft, destruction or damaging of The Beach property is strictly prohibited.
- p. Fighting, boisterous conduct, profane or obscene language, or harassing others, either verbally, physically or sexually is strictly prohibited.
- q. Cars illegally parked in a handicap space or fire lane are subject to towing at the car owner's expense.
- r. The Beach reserves the right to refuse entry to anyone wearing clothing with wording or designs that may be deemed inappropriate. Proper attire must be worn at all times.
- s. Proper language, etiquette, and courtesy shall be practiced at all times.
- t. Except with the permission of The Beach, no person can do any of the following: 1) charge fees or solicit anything; 2) sell or offer for sale any food, drinks, merchandise or service or conduct any commercial business activities of any kind; and/or 3) post, display, distribute or erect any advertising, notice, billboard, paper or other advertising device, information or materials.
- u. No practicing or warm up on or around concrete walkways, spectator areas or parking lot. Practicing and warm up shall be done in designated areas only.
- v. Upon entering The Beach, a person consents to video monitoring.
- w. Tents and shade canopies are allowed on-site but cannot exceed 10 x 10 and cannot contain any logos.
- x. All Rules and Regulations and policies of The Beach and of any third party sponsors or promoters must be followed.
- y. The Beach reserves the right to eject any person for violating the Rules and Regulations for the Facility.
- z. The Rules and Regulations are subject to change at any time in the sole discretion of The Beach's management.
- aa. **VIOLATORS OF RULES AND REGULATIONS WILL BE ASKED TO LEAVE THE PREMISES.**

### Lightning Policy

To provide a safe environment, The Beach has established guidelines and procedures for inclement weather. Lightning is a hazard that must be taken seriously by everyone. However, even when the skies look relatively clear, a lightning strike can still occur. This policy serves to inform everyone at The Beach of the guidelines to utilize when thunderstorms approach, as follows:

1. Thunder and lightning necessitates that all play of whatever nature must be suspended everywhere on The Beach property.
2. If an event is being run by an outside third party, a plan for shelter should be discussed and explained by such third party prior to the start of any event.
3. Everyone should immediately seek shelter inside the building or in a vehicle anytime they believe lightning threatens them even if they are not instructed to do so.
4. When thunder is heard and/or when lightning is seen, the following procedures should be adhered to:
  - a. You must suspend play. All participants and spectators should go inside the building or inside a vehicle with a solid metal top (e.g. bus, van, car).
  - b. Do not stand under or near a tree. Stay away from poles, metal fencing, high places, open areas, overhead wires, power lines, telephones and cellular phones, radios, golf carts, any standing water, antennas, and underground watering systems.
  - c. After thunder and/or lightning have left the area, wait approximately **30 minutes** after the last boom is heard or strike is seen before resuming play or competition.
5. The Beach does not provide any covered shelter from thunder and lightning. Everyone who enters The Beach needs to have a vehicle available to seek shelter. Parents are responsible for the safety of their minor children even when left unattended so Parents are encouraged to stay with their children at The Beach. Parents must discuss this policy with the child and make him or her aware of what vehicle will be available to seek shelter in the absence of the parent.

### Open Wound Policy

Anyone who is bleeding or who has blood on his/her clothing shall be prohibited from participating in any activity at The Beach until appropriate treatment has been administered. If medical care or treatment can be administered in a reasonable amount of time, the individual would not have to leave The Beach. What is considered "reasonable" shall be determined by the official(s) in any competition or if an official is not used, then the director of such competition.

Due care must be taken when dealing with anyone who is bleeding or has an open wound in order to avoid potentially contracting blood-borne diseases. Anyone participating in an activity at The Beach who is bleeding must contact either the official, director of such competition or management for The Beach. Any residual blood must be properly cleaned up prior to the recommencement of play.
